1. DETERMINATION OF LEASE HOLD RIGHTS IN R/O LAND RESERVED FOR ORNAMENTAL GARDEN IN GLR SY.NO.52/15, SHASTRI BAZAR DELHI CANTT

A piece of land measuring 3.89 acres comprising of GLR Sy.no.52/15 Shastri Bazar, Delhi Cantt, classified as B-3 land under the management of Delhi Cantonment Board was leased out to L.Gopinath in Sch.VI of CLA Rules 1925 for a period of 30years w.e.f 09.06.1932 renewable at the option of lessee upto 90 years. The site was leased out for the purpose of shops, dwelling houses and ornamental garden.

2. The second term of lease had expired on 8.6.1992 and further the Directorate DE, WC Chandigarh vide their letter No. 21/4090/Lands/WC/DE/104 dated 11.1.1996 accorded sanction for IIIrd term renewal of lease for a further period of 30 years w.e.f. 9.6.1992 upto 8.6.2022 in favour of Sh. Ajay Gupta, on payment of annual rental of Rs. 527/-. Sh. Ajay Gupta had executed renewal lease deed in schedule IV of the CLA Rules, 1937.

3. As per record the entire leased area of sy.no.52/15 i.e. 3.89 acres is for shops dwelling houses and ornamental garden and stands in the name of Sh.Ajay Gupta. In the year of 1990 Sh.Ajay Gupta sold the lease hold rights of the entire built-up area i.e. Shops & dwelling house to 36 person and further purchasers have also sold out lease hold rights to other persons without obtaining prior permission of the competent authority. Presently there are 41 sub-division of lease hold rights exist in sy.no.52/15. The lease hold rights of the ornamental garden still stand in the name of Sh.Ajay Gupta. The term of the lease is in its final leg and will expire on 08.06.2022.

4. Since 1932 from the date of commencement of the lease, the recorded lessees have not developed ornamental garden. It may be seen that in 84 years the lessees have not developed the ornamental garden. The Board has no vacant land for creating infrastructure. The vacant land in Sy.no.52/15 meant for ornamental garden is considered most suitable for developing infrastructure for public interest and for better service to the Board. It is recommended that the vacant land in Sy.no.52/15 meant for ornamental garden be taken over by the Board after obtaining approval of the competent authority for determination of portion of land measuring 2.10 acres in Sy.no.52/15 meant for ornamental garden. The Board may consider issue of determination of portion of leased land in sy.no.52/15 meant for ornamental garden and reclassification of this portion of land from B-3 to Class-C and management of the land be vested with the Board.

Reference Dte Gen DE, Delhi Cantt letter No.25/Misc/C/DE/2004 dated 18.11.2016, (copy enclosed) and discussions held during Conference of IDES Officers in Delhi on 11.11.2016 on the subject.

2. As you are award flow of funds from Ministry of Defence for undertaking various activities by Cantonment Boards is not enough. In many Cantonments Boards internal resources of revenue generation have not been raised as expected. It was decided during the Conference, that CEOs will have to take required timely action to complete triennial assessment, recovery of dues, etc.

3. It was also pointed out during the Conference that feasibility of bringing up viable and demand driven commercial ventures in Cantonments be considered seriously. In this regard you are directed to select suitable sites and the activities to be run in such commercial ventures, taking into consideration security concerns as well as to keep character of cantonments intact. You may also send proposals for review of boundary of civil area in terms of existing instructions/ guidelines and find out suitable location for bringing up commercial ventures in the proposals. Selection of sites should be normally of land under your management to avoid unnecessary complications.

4. The above details may be submitted to this Dte by 31.12.2016 positively for our examination and submission of feed back in this regard to Dte Gen DE by first of Jan, 2017.

3. CHANGE OF PURPOSE OF LAND

Sy. No.279, measuring 4.24 acres of land and Sy. No.143/1 measuring 0.239 acres of land are classified as class 'C' land under the management of Delhi Cantonment Board. Purpose of land of Sy. No.279 and 143/1 is trenching ground and rubbish dumping ground and approach road to trenching ground respectively. The trenching ground in Sy. No.279 is not in use for over last two and half decades. It is proposed to change the purpose of class 'C' land in these Survey Nos. from trenching ground and rubbish dumping ground including approach road to land meant for infrastructural development for revenue generation. The Board may consider.

4. RECLASSIFICATION OF LAND

It is brought out that Village Mehram Nagar is located in Sy. No.165 classified as class 'C' land. The surrounding land of Village Mehram Nagar is class B-4 land under the management of DEO Delhi Circle, Delhi Cantt. This land is bounded by a boundary wall. The surrounding land of Village Mehram Nagar comprising of Sy. No.167/1, 276 and 235 which is B-4 land is being used by the Board for provisioning of various services and civic amenities to the residents of the village. In these Survey Nos. the Board has provided three Water supply installations, Sulabh Sauchalaya, Parks, Sewer pumping station, Cremation ground and Gym etc and this land has also been used by the Board for laying of water pipe lines, electrical cables and sewerage lines etc. The land in Sy. No.167/1, 276 and 235 is being widely used by the Board for various services and infrastructure complementary to the residents of Village Mehram Nagar. It is proposed to reclassify the land in above Sy. Nos. from B-4 land to class 'C' land and placing land under the management of the Board for the purpose of infrastructural improvements, Community facilities and for revenue generating schemes. The Board may consider reclassification of land from B-4 land to class 'C' land.

5. REJUVENATION OF SABZI MANDI, SADAR BAZAR, DELHI CANTT

At Sadar Bazar the Board has created a Sabzi Mandi which is more than two and half decade old. The Sabzi Mandi is situated in Sy. No.49/41 which is classified as B-4 vacant land under the management of Delhi Cantonment Board. The area occupied by the Sabzi Mandi including approach roads etc is about 7,500 sqft. The Sabzi Mandi in its present design does not fulfill the requirements of modern shopping and the design and layout of stalls in Sabzi Mandi do not provide for fire exits and the whole complex does not fulfil design requirements of National Building Code, 2005. The stalls are single storied and thus optimal utilization of precious land does not exist.

It is pertinent to mention here that from July, 1991 onwards the allotment of 50 stalls at Sabzi Mandi were made at license fee of Rs.100/-

per month and license was granted for eleven months. The license agreement was executed with the licensees which provide for handing over of vacant possession after expiry of license period. After expiry of license period the occupiers have not paid any money to the Board.

It is proposed to redesign, reconstruct the project with optimal utilization of land, in multi-storied construction for shops, offices and commercial purposes with adequate two level parking facility on PPP Model. The licensee/ legal heirs of stalls in the Sabzi Mandi may be considered for rehabilitation by the Board at alternative location and terms and conditions as decided by the Board. The proposed project will allow optimal utilization of land and will help in creating infrastructure to meet growing demands of Cantonment residents and will generate considerable revenue to the Board. The Board may consider redevelopment of Sabzi Mandi at Sadar Bazar.

6. STRENGTHENING/ CREATION OF INFRASTRUCTURE

The land in Sy. No.201 comprises of area measuring 5.342 acres classified as class 'C' land for the purpose of Cantonment General Hospital. The portion of land in Sy. No.201 is presently being used for Cantonment General Hospital and staff accommodation. Most of precious land in Sy. No.201 is lacking optimal utilization of land. Cantonment Board has approved proposal for construction of staff qtrs in a portion of land in Sy. No.201 which is laying vacant. It is proposed to use this land for infrastructural improvements, construction of staff qtrs & for revenue generation schemes/ projects on PPP Model. The Board may consider.

It is proposed to designate Sh. Sunil Kataria, Horticulturist as Central Public Information Officer, Delhi Cantonment Board.
