The financial implication on the enhanced Dearness Allowance will be Rs.17,30,000/- approximately for the year 2017-2018.

### **4. PAYMENT OF AD HOC BONUS TO THE CANTT BOARD EMPLOYEES DELHI CANTT FOR THE ACCOUNTING YEAR 2016-2017**

To note and approve expenditure incurred amounting to Rs.33,28,614/ on account of Ad-hoc Bonus to Cantt Board Employees for the year 2016-17. For above, Govt. of India, Ministry of Finance, Department of Expenditure New Delhi letter No. 7/4/2014-E. III A dated 19.09.2017 forwarded by Deputy Secretary Finance (Budget) Department, Govt of N.C.T. of Delhi letter No. F. 31/Fin. (Estb-III)/2017/dsV/1118 dated 21.09.2017 for the grant of Non-Productivity Linked Bonus (Ad-hoc-Bonus) equivalent 30 days emoluments for the year 2016-17, the average emoluments in a year will be divided by 30.4 (average number of days in a month), the calculation ceiling of monthly emoluments of Rs.7000/- (where actual average emoluments exceed Rs.7000/-). Non PLB (Ad-hoc Bonus) for thirty days would work out to  $Rs.7000 \times 30/30.4 = Rs.6907.89$  (rounded off to Rs.6908/-). The Ad-hoc Bonus amounting of Rs.6908/- would be applicable to each Central Government employees in Group C & D and all non-gazetted employees in Group B who are not covered by any Productivity Linked Bonus Scheme. The payment will also be admissible to Cantonment Fund Servants (Group C & D) and non-gazetted employees in Group B.

The necessary budget provision has already been made in the Budget Estimates for the year 2017-18 (Revised)

## **5. BUILDING PLAN : PLOT NO.22, THIMMAYA MARG, DELHI CANTT**

Shri Arvind Dumra, Smt. Manju Dumra and Sh. Amith A Dumra had submitted building plan dated 17.03.2016 for the leased property bearing No.22, Thimmaya Marg, Delhi Cantt for sanction of Competent Authority. The building plans were checked by the Engineering Branch and were returned back un-actioned vide this letter No.DCB/BP/AKD, MD, AAD/2015-16 dated 19.04.2016 as the applicants had not submitted building processing fee. The building plans were re-submitted by the applicant which were returned back twice intimating deficiencies in the plans vide this office letter No.DCB/BP/AKD,MD/AAD/2015-16 dated 16.06.2016 and letter of even No. dated 26.09.2016. The applicants made good the deficiencies and re-submitted building plan on 10.11.2016 and again submitted revised building plan on 21.02.2017 with a request to ignore the earlier building plans which were submitted by them. The building plan submitted on 21.02.2017 have been scrutinized by the Engineering Branch on the parameters contained in the existing building bye laws and are found complying with the applicable Building Bye Laws notified by the Govt. on 08.06.2002. As the property is lease hold under the management of Defence Estate Office, Delhi Circle it is recommended that, may the building plan be forwarded to Defence Estate Office u/s 238 (3) of the Cantonment Act, 2006 for obtaining NOC from land point of view.

## **7. GRANT OF REVISED RATES OF ALLOWANCES TO CANTONMENT FUND SERVANTS BASED ON THE RECOMMENDATIONS OF 7<sup>TH</sup> CPC.**

To consider grant of revised rates of allowances to Cantonment Fund Servants based on the recommendations of 7<sup>th</sup> CPC.

2. As per the Memorandum of Settlement reached between the Cantonment Board and the workmen on 13.05.1969, it has inter-alia been agreed that the pay and allowances of Cantonment Board employees broadly be equated with those of similar categories of State Govt. Accordingly, revised pay scales, subsequent to the implementation of the 7<sup>th</sup> CPC have been made applicable to the regular employees of the Delhi Cantonment Board based on the Delhi Govt. orders and on the recommendation of the Board vide CBR No. 07 dated 29.08.2016 after obtaining the sanction of the Competent Authority. Consequent upon the implementation of 7<sup>th</sup> CPC recommendations on Allowances as modified by the Govt., payable to Central Govt. employees, the State Govt. of NCT of Delhi has also adopted the payment of revised rates

of allowances based on the orders issued by the Ministry of Finance/Ministry of Personnel, Public Grievances and Pensions. The details in this regard are given below:-

It is therefore proposed to grant revised rates of allowances w.e.f. 01.07.2017 to the Cantonment Board Employees as per the details mentioned above.

2. The financial implication on account of payment of revised rates of allowances will be to the tune of ` 3 Crores approximately per year. Necessary provision in this regard has been made in the Budget estimates for the year 2017-18. The Board may consider the same for concurrence so that the case may be taken up in this regard with PDDE, WC for obtaining the sanction of the Competent Authority.

#### **8. IMPREST MONEY TO PERMANENT DOCTORS OF CANTONMENT GENERAL HOSPITAL**

To note and approve Office Order No.103 dated 01.11.2017 regarding providing of Imprest Money of Rs.25,000/- each to all permanent doctors of Cantonment General Hospital to meet out day to day expenditures like purchase/ repair/ replacement of any part of medical instruments, consumables, medicines etc which they seems to be essential in nature.

#### **9. LORETO CONVENT SCHOOL : ISSUANCE OF COMPLETION CERTIFICATE**

The Cantonment Board vide its resolution contained in CBR No. 45 dated 08.03.2016 had considered the building plans submitted by Loreto Convent School, Delhi Cantt and the Board had resolved to forward the building plans to the DEO, Delhi Circle for obtaining NOC from land point of view. The case was processed by the DEO, Delhi Circle for obtaining approval of the GOC-in-C, Western Command to the proposed construction on GLR survey no. 105/1 in terms of conditions 1(5) of the lease deed held in Schedule VIII CLAR 1937. After lengthy correspondence the sanction of GOC-in-C, Western Command was received and was communicated by the Office of the Dte. vide letter No. 21/1334/L/DE/WC dated 28.02.2013. The DEO, Delhi Circle thereafter accorded NOC from land point of view in respect of building plan submitted by Loreto Convent School vide their letter No. 3/840/DEO/IV dated 03.05.2013. The sanctioned building plans were released to the Principal, Loreto Convent School by the Office of the Cantonment Board on 05.06.2013. The sanction accorded by the Board for building construction was valid for a period of one year.

The school authority could not commence the work at site as the cutting of ten trees at site was delayed. In this connection Principal, Loreto Convent School letter No. LC/Audi/2013/2 dated 06.09.2013 also refers. It is pertinent to mention here that Loreto Convent School is situated on 10 acres of land comprising of survey no. 105/1,

and land was leased out to the school in Schedule VIII of CLAR 1937. The lease of the land expired on 20<sup>th</sup> September, 2014. Due to delay in sanction of building plan and delay in commencement of construction due to cutting of trees, the construction could not be completed within the period of one year as provided in the sanction letter. The school authorities communicated that the construction was completed in all respects in December, 2016 and had requested for issue of completion certificate as per provisions of the Cantonments Act 2006. The site was inspected by the Engineering Branch and the newly constructed portion was found to be complying with the sanctioned building plan. The school authorities did not seek timely extension for the building construction as required under Section 244 and 245 of the Cantonments Act 2006. As the lease of land given to the Loreto Convent School has since expired on 20.09.2014 and the case of renewal of lease is pending. However for renewal of lease completion certificate of the newly constructed building or certificate would be required by the Competent Authority to ascertain that the new construction is not in deviation to the sanctioned building plans and that the completion certificate can only be issued if the extension for completion of building under Section 245 of the Cantonments Act 2006 is granted. The Board may consider issue of granting ex-post facto sanction for completion of building and release of completion certificate to the Loreto Convent School authorities.

**10. RECOGNIZATION OF DELHI CHAWANI PARISHAD KARAMCHARISANGATHAN.**

Delhi Cantonment Board Employees Union has requested for recognition of Delhi Chawani Parishad Karamchari Sangathan vide letter dated 09.09.2016 from Shri. Hardayal Chauhan, General Secretary.

2. In accordance with the guidelines issued by the DGDE vide letter No. 25/37/JCM/C/DE/2011 dated 26.8.2013, the CCS(RSA) Rules, 1993 and instructions issued by DOP&T from time to time shall apply for grant of recognition, to Associations. The Cantonment Board shall be the Competent Authority to grant the recognition,. The main criteria to be recognized is that the association should represent at least 35% of total number of employees in a particular category. The primary object of the association is to be of promoting common service interests of members of a distinct category. Subscription should be deducted from pay rolls on written consent of the officials in favour of a particular association. Check-off system of verification should be followed to verify the membership of an association on the basis of deduction of subscriptions.

3. Delhi Chawani Parishad Karamchari Sangathan is affiliated to All India Cantonment Board Employees Federation vide their letter dated 25.1.2017. As per Accounts Branch, a total of 198 employees have subscribed to the membership of Delhi Cantonment Board Karamchari Sangathan, which works out to more than 35% of the 502 employees currently on roll of the Delhi Cantonment Board vide Accounts Branch I.O.N No.DCB/12/VI/Acctts dated 24.4.2017.

4. The Sangathan has submitted the following information/documents, as required, under the rules for its recognition, in their letter dated 9.9.2016:-

5. The Sangathan thus prima facie fulfills the requirements for recognition of Service Association. The Board may consider grant of recognition to the Delhi Chawani Parishad Karamchari Sangathan, subject to the usual/standard terms and conditions as laid down in the CCS (RSA) Rules, 1993 and the instructions issued by DOP&T from time to time.

#### **11. ENGAGEMENT OF MEDICAL AND PARA-MEDICAL STAFF ON CONTRACTUAL BASIS FOR CGH**

Reference CBR No. 8 dated 06.10.2016

2. It was directed by DGDE vide their letter No. 25/Misc/C/DE/2004 dated 06.10.2016 inter-alia that all the contractual staff should be engaged through outsourcing only, and not by the Cantonment Boards directly as such direct engagement lead to litigation on account of claim for regularization of such contractual staff. This was considered vide CBR No. 8 dated 06.10.2016, and the Board carefully noted the directions issued by the office of Dte General, Defence Estates vide their letter dated 06.10.2016 and the directions issued by the Dte. DE Southern Command dated

27.06.2016 as brought out on the agenda side. The Board also noted that the CEO, Member-Secretary has already initiated action for recruitment of few vacant posts. The CEO, Member-Secretary informed that notice for recruitment of other vacant posts will also be issued soon. The Board resolved to authorize the CEO, Member-Secretary to implement directions issued by the competent authority at the earliest & authorized him to incur necessary expenditure in this regard.

3. In this connection it is pertinent to mention that the feasibility of engaging hospital staff through outsourcing has been explored by this office and for this purpose, a Committee consisting of the following officials was constituted:-

- a) Dr. Parveen Pratap Singh, Sr. GDMO.
- b) Dr. Ajay Kumar Singh, GDMO.
- c) Mrs. Vijay Madhu Sr. Clerk.

The Committee has since rendered its report which is enclosed herewith. According to the recommendation of the Committee:-

- (a) Medical and Para medical service being of specialized nature (unlike the security and housekeeping services) cannot be compromised at any stage of their execution. No interruption for want of such service can be accepted.
- (b) Therefore to ensure uninterrupted and reliable service of medical and paramedical staff, it would be prudent to engage such manpower through the process of direct recruitment only.

4. In view of the forgoing it is felt that status quo ante of engaging contractual Medical and Para-Medical staff for CGH directly by the Board should be maintained so that provision of uninterrupted and Medical Care to the patients does not suffer. The Board may consider the same and if agreed to, DGDE may be informed suitably in this regard.

## **12. RENEWAL OF COMPREHENSIVE MAINTENANCE CONTRACT OF 4 LIFTS WITH EQUIPMENTS MANUFACTURING AGENCY.**

The annual comprehensive maintenance contract of 4 lifts installed at CB Office and CG Hospital was due to expire on 31.10.2017. M/s Emaan Elevators Pvt. Ltd., the manufacturing agency vide their letter No.DEL/EE/DCB/17 dated 25.09.2017 have submitted offer of comprehensive maintenance of lift @ 9870/- plus GST per lift per month. The existing rates are Rs.9400/- per month per lift. The comprehensive maintenance contract for lifts is recommended for renewal w.e.f. 01.11.2017. The Finance Committee may consider offer.

2. Information was sought from all field offices in a format in CB data regarding implementation of rotation policy. Field offices were asked to identify sensitive and non sensitive posts and implement the rotation policy in their offices. It has been observed that there has either been no compliance of DOP&T instructions or only a perfunctory compliance by most of the offices.

3. It is to be noted that the Central Vigilance Commission (CVC) and DoP&T have issued numerous instructions regarding rotational transfer of officials posted in sensitive posts at periodic intervals. The intention behind these instructions is to ensure probity in governance, prevention of development of vested interests by the concerned officials and also ensure the growth and career development of the employees by way of job satisfaction by giving them opportunity to work at varied jobs. A Committee of Secretaries (COS) has also been appointed to monitor the progress. This Committee in its meeting, held on 12<sup>th</sup> June, 2017 has instructed the MoD to identify all sensitive posts and furnish a report within one month. MoD id no. 26/1/2015/D(Lab) (vol.II) dated 20 June, 2017 is enclosed herewith.

4. It is reiterated that the Head of Office is responsible for identifying sensitive posts. Generally, posts which are related to procurement, execution of works, release of payments, posts in revenue/ accounts branches, transfers, promotions, auctions, services to be provided to the public and dealing with confidential matters can be classified as sensitive. Officials doing field jobs such as Sanitary Inspectors, SDOs, Engineers in Cantonment Board etc. must be rotated in respect of their jurisdiction once in three years, wherever there are more than one official in that category. In places where rotation of persons is not possible due to stand alone posts, details of such posts should be brought out clearly.

5. All field officers are, therefore, again advised to identify sensitive posts and effect transfers wherever required and submit a report in respect of their office to this Dte not later than 15<sup>th</sup> July, 2017 in the proforma enclosed herewith.
