### Public Notice

1. Whereas in compliance to Hon'ble High Court of Delhi order dated 01.02.2017 Survey under Sec 4 & 11 of "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act /Rules 2013" for detecting insanitary latrines/ manual scavengers in Delhi Cantt area was carried out by Delhi Cantonment Board w.e.f 01<sup>st</sup> Aug 2018 to 30<sup>th</sup> Aug 2018 as per the programme of survey, notified vide public notice No. 8 dated 11.07.2018, was published in two newspapers i.e. Times of India and Dainik Jagran on 29.07.2018. A "Self Declaration Centre" was also established by Delhi Cantonment Board for the above purpose.
2. During the course of survey no insanitary latrine and manual scavenger was detected nor any person declared his/ her involvement in manual scavenging work in Delhi Cantonment area.
3. Delhi Cantonment Board also surveyed different schools located in Delhi Cantt area. Certificates have been furnished by School Principals stating that there is no insanitary latrine/ manual scavenger in areas falling under respective areas of the concerned school managements.
4. Communications were also sent to Heads of different civil organisation/ Offices of Govt Deptt and HQ of Armed Forces e.g. Station Delhi Cantt, Western Air Command, Air Force Station Palam/ Navy Formations etc. under whose administrative control there are land parcels and buildings in Delhi Cantt. These Organisation/Depts/HQs have not reported existence of any insanitary latrine/ manual scavenger, accordingly these Organisation/Depts have furnished nil report.
5. Besides the above, a committee constituted under the provision of Sec 4 of "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Rules 2013" visited the area/ localities of different location of concentration of Safaikaramcharis and other part of the Cantt as on 30.8.2018 to enquire about existence of insanitary latrine and manual scavenger, if any. The committee has submitted a nil report in the subject matter.
6. Now based on survey conducted by Delhi Cantonment Board as well as reports received from different ends, it is hereby published on provisional basis that there is no insanitary latrine and manual scavenger in existence in Delhi Cantonment area. If

anybody is working as manual scavenger (for definition of manual scavenging Sec 02 of "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013" may be referred) he/ she may file his/ her written claim within 15 days from the date of publication of this notice in prescribed format, which could be obtained from Sanitation Branch of Delhi Cantonment Board during working hrs free of cost which may also be downloaded from the website of Delhi Cantonment Board ([www.cbdelhi.in](http://www.cbdelhi.in)) or can be seen on Notice Board of Cantt Board. Claim shall be supported with documentary evidence, if any. Claim received after the aforesaid prescribed period, for what so ever reason shall not be considered.
