Engagement of upto 05 Junior Advocates on Full Time Retainership Basis

1. Number of Vacancy – 05 (Five)
2. Eligibility Conditions:
 - Degree in Law with 55% marks in the aggregate (where B.A. & L.L.B. have been completed separately 55% in each).
 - Maximum Age: 35 years as on June 30, 2017.
 - 18 months post qualification experience of litigation matters in courts in Delhi. Candidates who have registered themselves with the Bar Council of Delhi (or other state councils) before December 31, 2015 only are eligible to apply.
 - Good communication and comprehension skills. Fluency in English is a must.
3. Terms and Conditions of Engagement:
 - a. The successful candidates shall be engaged as Junior Advocates on full time retainership basis with the Board, initially for a period of 11 months extendable on year to year basis, based on the requirement of the Board & performance of the candidate.
 - b. The Junior Advocates shall be required to appear in courts on behalf of the Board, vet written statements, affidavits, agreements and contracts, manage legal matters on behalf of the Board and execute other assignments that may be entrusted to them.
 - c. The Junior Advocates shall be paid a minimum of Rs. 30,000/- pm as Retainership fee. However, the retainer-ship fee is negotiable and shall be commensurate with the experience and qualification of the candidate and current market standards.
 - d. The Junior Advocate shall not be allowed to indulge in any other professional activity.
4. Procedure for Applying:

 - f. Self-attested copy of Bar Council Registration and Certificate for Practice.
 - g. Self-attested copies of Experience Documents.
 - h. Passport size photograph.
 - A colored scanned copy of the above application is to be attached to the e-mail with the subject line 'Application for Position of Junior Advocate'. Eligible candidates shall be called for interview. The original application and the documents will have to be deposited at the time of the interview.
