CONDITIONS FOR RECRUITMENT:

1. The upper age limit is relaxable for the reserved categories as per Govt. rules. Candidates claiming age relaxation under reserved category must attach self-attached copy of the certificate in support of the same, issued by the competent authority. Reservation (s) will be as per the directions of the competent authority. The existing ad-hoc/short-term staff of CG Hospital, Delhi Cantt will be given age relaxation to the extent of their service in the Hospital, Delhi Cantt-10 subject to relevant experience certificate.
2. The Engagement will be initially for a period of 89 days (04 hours/day, 03 days a week) which is extendable further depending upon the requirement of the Hospital and satisfactory performance of the staff.
3. The Candidate must be registered with Delhi Dental Council/DCI.
4. The application in the prescribed format as below, must be sent in an envelope duly super-scribed with the Name of Post, Engagement Notice No & Date, along with two self-attested photographs, address proof (Voter ID/Aadhar Card/Passport etc.) & self-attested copies of the testimonials in proof of their age, Academic Qualification, Council registration, Experience, Attempt Certificate (if applicable) so as to reach the office of the Chief Executive Officer, Delhi Cantonment Board, Sadar Bazar, Delhi Cantt-10, on/before 27.8.2018.

5. The Candidates will have to abide by the terms & conditions of Delhi Cantonment Board/ C.G. Hospital. They will not be entitled to any other financial benefits other than the consolidated remuneration (Subject to TDS) stated above.
6. The Selection Committee may shortlist the candidates for interview on the basis of their marks of qualification examination/relevant experience, OR it may conduct a test for the purpose.
7. All relevant notices including the list of shortlisted candidates (if applicable) for the interviews will be published on the website (www.cbdelhi.in)/ CG Hospital notice board which the candidates are advised to view regularly.
8. No TA/DA will be given for appearing in the test/ interview. Canvassing of any kind will lead to disqualification.

10. Selected candidates shall be allowed a maximum of 07 days' time for accepting the offer of appointment and thereafter 07 days for joining from the date of acceptance, failing which the offer shall stand cancelled.
