TERMS & CONDITIONS

1. Only the Govt. Agencies (NTC, Khadi Gramodyog, DSIIDC & Kendriya Bhandar etc.) shall participate in the tender.
2. The agencies is bound by all rules and regulations and terms and conditions fixed by the Cantonment Board, Delhi.
3. Cantonment Board Delhi reserves to itself the right to reject conditional tenders without assigning any reasons thereto.
4. Cantonment Board Delhi reserves to itself the right to reject any or all the tenders without assigning any reasons thereof and to call for any other detail or information from any of the tenderer(s).
5. Cantonment Board Delhi is not responsible for any postal delay etc. in respect of submission/receipt of any documents.
6. The tender/contractors offering the lowest bid are to supply the goods according to supply order issued by this office time to time as and when required.
7. The Cantt. Board is not bound to purchase the articles given to the tender notice but the contractor shall be bound to supply any over the above quantity mentioned at the rates mentioned above.
8. No/duplicate/fake goods other than as per specification will be accepted.
9. In case of violation of any terms and conditions the Cantt Board Delhi Cantt reserves the right to black list the agencies or and debarred the agencies from submission of tenders of the Cantonment Board, Delhi Cantt in future as it may deem proper.
10. The rates should be quoted inclusive of all taxes with freight charges except GST. This office pay GST extra to the supplier if applicable. The goods are to supplied by the agencies at Cantonment Board Office or our site situated in Delhi Cantt area.
11. Contractor shall give their full address in the tender & will keep the Cantonment Board office informed about the change of their address if any.
12. The contractor shall not transfer/sublet the contract to any other contractor/person.
13. The length and breadth of each sample of fabric should be at least 10"x 10" and sample of saree should be in single piece wise.
14. The quantity of the required fabric/ items of uniform will be intimated at the time of placement of supply orders as per requirement from time to time.
15. The samples will be selected by duly constituted Tender Evaluation Committee of this department. One or more items of the same firm may be selected by the committee and accordingly, order shall be placed to the firm for one or more items. In other words, different firm may be awarded contract for different articles of uniform depending on quality and rates. The decision of the committee will be final and binding on all bidders.
16. The bidders must have at least 3 years' experience for supply of uniform items in central Govt. Ministries/Departments/PSUs. Necessary supporting documents to the effect be enclosed.
17. Bidders are requested to furnish their complete address and telephone numbers along with PAN/TAN, GST registration certificate etc.
18. A firm blacklisted by any Govt./state government office will not be eligible to participate in this tender. In case any such firm obtain contract by hiding this fact and it comes to the notice of this Ministry later, contract will be cancelled immediately and security deposit forfeited. The items of uniform already supplied will also be confiscated.
19. The bid document must be filled in neatly and clearly. Incomplete or conditional tenders will not be entertained.
20. Any request for increase in the approved rates will not be entertained for any reason for the contract period for any reason and the items required to be supplied by the contractor should strictly be in accordance with the samples approved.
21. Performance security is compulsory and will have to be deposited by each successful bidder.
22. TDS and other applicable taxes as per prevailing rates will be deducted before making the payment.
23. Payment against bill/invoice shall be released only after supply/inspection and observance of satisfactory supply of the uniforms. Payment will be made directly to the supplier. No advance payment will be made in any case.
24. The department reserves the right to impose any other conditions for regulating the contract in public interest.
25. In case the successful bidder is found in breach of any condition(s)/tender at any stage, legal action as per rules/laws shall be initiated against the agency concerned. In that case, EMD/ performance security shall be forfeited after giving proper opportunity through show cause notice.
26. Interested firms /parties will have to submit unconditional acceptance to the above terms and conditions at the time of submission of the quotation on the letter head of the firm.
27. The bidders who does not fulfill any of the above conditions and incomplete tenders are liable to be summarily rejected at the risk and cost of the bidder only and any further correspondence in this regard will not be entertained.
