1. The Registration of Candidates will be done from 9.30 AM-12.30 PM on 02 August 2019. If the numbers of candidates are more, then a written/Screening test will be conducted to shortlist the eligible candidates. The screening test of eligible candidates if required will be conducted on 06 August 2019 and in that case, the interview will be held on the same day /subsequently as decided by the Selection Committee. The eligible candidates should report in the office of CMO, Cantonment General Hospital, Sadar Bazar, Delhi Cantt at 9.30. A.M. on all dates.
2. The selection panel has the authority to reckon the marks obtained in B.D.S (and 12th standard in case of a tie) as selection criterion: as also to conduct practical examination, as considered necessary.
3. Candidates are required to submit completed application in the prescribed format along with a set of their self-attested photocopies of relevant documents with proof of their age, Academic Qualification (i.e. Degree/Diploma certificate) with mark sheets of all years, DCI/DDC Registration, Internship completion certificate, Attempt certificate (if applicable) experience and address proof (Voter ID/ Aadhar Card/ Passport/ Driving License etc.) and two passport size photograph at the time of registration. The original documents must be produced for verification at the time of interview/engagement.
4. Candidates claiming age relaxation under reserved category must attach self-attested copy of the certificate in support of belonging respective category, issued by the prescribed Authority.
5. No TA/DA will be given for appearing in the interview.

6. The competent authority reserves the right to change the number of vacancies, withdraw the recruitment process in full or part without assigning any reasons or giving any notice.
7. The decision of the competent authority with regard to selection will be final and binding and no representation will be entertained in this regard.
8. The list of selected candidates will be displayed on the main notice board of the hospital. No correspondence/personal enquires shall be entertained.
9. Selected candidates shall be allowed a maximum of 07 days' time for accepting the offer of appointment and thereafter 07 days for joining from the date of acceptance, failing which the offer shall stand cancelled.
